Toledo Metro FCU Partners with Lucas County Children's Services



Toledo Metro Federal Credit Union partnered with Lucas County Children's Services and the Fair Housing Center to provide emancipating foster youth with the resources that they will need to transition out of foster care as they enter adulthood.

Through this partnership, the Fair Housing Center is committed to educating teens on their rights and responsibilities as tenants to ensure housing success when they leave foster care.

Toledo Metro FCU provided the financial education classes and associated materials to all participants. In addition to the financial education classes, the teens were offered a savings account where every dollar saved was matched by the credit union. Teens who successfully completed the full curriculum will be awarded their choice of a Chromebook or tool allotment to help them prepare for college or trade school.

Financial resources were provided by the Ohio Credit Union Foundation's New Beginnings Grant.

The National Credit Union Administration (NCUA) is an independent agency of the US government that regulates, charters and supervises federal credit unions, like TMFCU. NCUA operates and manages the National Credit Union Share Insurance Fund (NCUSIF). Backed by the full faith and credit of the US government, the NCUSIF insures the accounts of millions of account holders in all federal credit unions and most state-chartered credit unions.

NCUA is committed to the protection of credit union members and the safety and soundness of the credit union system overall. No one has ever lost a single penny of insured share deposits within the credit union system.

Board of Directors Notice

The Nominating Committee of Toledo Metro Federal Credit Union has nominated two incumbents to serve you as Board Members. Both seats are for three-year terms.

Members interested in being nominated by petition should contact the President of Toledo Metro Federal Credit Union. Nominations require signatures from 1%, or about 65, of the credit union's membership. Petitions must be returned to the credit union no later than 5:00 p.m. on May 12, 2023.

The following must accompany the petition: a certificate stating the petitioner is agreeable to be nominated and will serve if elected; a brief statement of qualifications; member biographical data.

Board members are required to attend monthly board meetings, be willing to attend various committee meetings and possess required financial knowledge which may require training.

If any position is contested, that is, there are more nominations than available seats, voting will take place within 30 days of the Annual Meeting date, yet to be determined.

No nominations will be accepted at the meeting.
